7. Letter of Acceptance

CYDA India will issue Letter of Acceptance to the selected bidder after finalizing the L1 (Lowest Quote) from the bid documents. A successful bidder who fails to sign and send back the letter of acceptance will not be eligible for contract and hence the contract will be done with the L2 (Second lowest quote).

- 8. **Tender(s)** have to be mandatorily submitted by interested bidders through

- **9.** All Bids must reach CYDA India well within the last date and time for submission of Bid as specified above at 6b.
- 10. Site visit: Bidders are advised to inspect and examine the site and the surroundings and satisfy themselves before submitting their Tender. Submissions of the Tender by the Bidder implies that he/she has read this notice and all other tender documents and has made him/herself aware of the scope and specifications of the work to be done and local conditions and other factors bearing on the execution of the works.
- 11. Cost of Bidding: The Bidder shall bear all costs associated with the preparation and submission of its bid, and CYDA India shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- **12.** Language of Bid: The Bid, as well as all correspondence and documents relating to the bid exchanged by the Bidder and CYDA India shall be written in the English language. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by translation of the relevant passages into the English language (in which case English translation of the documents shall prevail).
- 13. Alternative Bids: Any bid with alternative options/price quote shall not be considered.
- **14.** Currency of Bid: Bid should be submitted in Indian Currency and contract shall also entered in the Indian currency.
- **15.** IF ANY INFORMATION FURNISHED by the Bidder is found to be incorrect/false or not true at a later stage, the said Bid shall be liable to rejection/disqualification and further actions including termination of contract will be initiated by CYDA India.

- **16.** CYDA India retains the right to cancel the bidding procedure altogether, if unethical practices from the bidder or bidder collusion for price setting is found to have taken place during the bidding.
- 17. CYDA India does not bind itself to accept the lowest or any tender or to give any reasons for their decision.
- **18.** This notice of Tender shall form part of the contract documents.
- 19. There will be no escalation of contract value and the contract value is inclusive of applicable GST.
- 20. Successful bidders shall have to sign the applicable policies of CYDA India.
- **21.** The bidder shall have to repair the work without any further cost to CYDA India if any defects are observed within six months of completion of work as per final completion certificate of the work.
- **22.** At any time prior to the deadline for submission of bids, CYDA India may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, modify the bid document. In such case, CYDA India may extend the deadline for the submission of bids & notify it.
